

### PortfolioPlus S&P Small Cap ETF

#### Overview

The PortfolioPlus S&P® Small Cap ETF (PPSC) is formerly the Direxion Daily Small Cap Bull 1.25X Shares (LLSC). The fund's name and ticker was changed on February 15, 2018.

The PortfolioPlus S&P® Small Cap ETF seeks daily investment results, before fees and expenses, of 125% of the daily performance of the S&P Small Cap 600® Index. **There is no guarantee the fund will meet its stated investment objective.**

This leveraged S&P Small Cap ETF seeks a return that is 125% the return of its benchmark index **for a single day. The fund should not be expected to provide 1.25 times the return of the benchmark's cumulative return for periods greater than a day.**

Investing in PortfolioPlus ETFs may be more volatile than investing in broadly diversified funds. Compounding affects all investments, but has more impact on leveraged funds, particularly during periods of higher index volatility and longer holdings periods. Returns may be negative in the same period that the index returns were flat or positive. PortfolioPlus ETFs are intended to be used by investors who understand leverage risk, the effects of compounding and who intend to monitor their portfolios.

#### Target Index

The S&P Small Cap 600® Index (SPTRSMCP) attempts to measure the performance of 600 small-capitalization companies in the U.S. The Index is a float-adjusted market capitalization weighted index. Standard & Poor's® selects companies with unadjusted market capitalizations of \$450 million to \$2.1 billion (USD) and based on market values, liquidity, financial viability and industry diversification. **One cannot directly invest in an index.**
